# RUSH FIRE DISTRICT, BOARD OF FIRE COMMISSIONERS

1971 Rush-Mendon Road, Rush, New York 14543 Unapproved Minutes – August 16, 2016

**Roll Call:** Chairman Robert Faugh called the meeting to order at 7:00 p.m. followed by the Pledge of Allegiance to the Flag.

**Present**: Commissioners Robert Faugh, Michael Terzo, Lawrence Meston, Scott Goodman, Dale Sweet, Secretary Colleen Statskey and Treasurer Robert Kuhls.

Representing the Rush Fire Department was Chief James Bucci and Assistant Chief James McNeil.

Representing the Town of Rush was Councilwoman Jillian Coffey.

**REPORT FROM THE TOWN:** Councilwoman Jillian Coffey spoke regarding suspicious activity reported at House #2. Commissioner Dale Sweet reported camera surveillance cameras will be installed. The Town Highway Department LED project has been completed. The Rush Associates rezoning is on the agenda for next board meeting. Commissioner Michael Terzo inquired about the Fire Department being able to continue to use the BOCES property for training.

**APPROVAL OF MINUTES**: The Minutes of July 19, 2016, were approved with an addition under NEW BUSINESS Treasurer Robert Kuhls reported the 2016 taxable assessed valuation is \$306,567,371.00, an increase of \$1,417,659.00 for the Rush Fire District.

A motion was made by Commissioner Michael Terzo, seconded by Commissioner Dale Sweet and approved 5 to 0 to accept the Minutes of July 19, 2016, with the addition made.

### AREAS OF CONCERN:

**COMMUNICATIONS:** None.

**FIRE MARSHAL**: Chief James Bucci reported he will set up a meeting with Fire Marshal Rick Tracy and the Town Supervisor regarding residents in the town that need to clean their driveways for fire equipment to have adequate access to their property. The Krenzer property on West Henrietta Rd. had an open burn with no burning permit.

**NEW EQUIPMENT:** Commissioner Michael Terzo reported the new air bottles have arrived and the valves will be switched. Chief James Bucci reported a petrogen

cutting torch system out of the Chief's budget roughly \$1600.00 plus the lease of a O2 cylinder. Commissioner Michael Terzo purchased 2 cordless drills at \$79.00 a piece for the rescue truck.

**TRAINING:** Chief James Bucci reported 2 cars coming for extrication/EMS drills. PSTF in October with Honeoye Falls. Commissioner Michael reported MCC is now offering Fire Instructor 1. Firefighter Mike Terzo, Jr. would like to take the course. Assistant James McNeil reported an estimate of \$550.00 with meals, etc. Andrew Socola is signed up for Vital Signs in Syracuse.

HOUSE #1: Commissioner Michael Terzo reported the bushes and the tree was trimmed. After Saturdays storm a tree out front was lost. Commissioner Michael Terzo to contact O'Neill landscaping to grind down the stump. Commissioner Michael Terzo has a price for the white fence and will obtain another quote. Commissioner Lawrence Meston reported Larry Kaplan going to replace the control box in the pit after ordering the parts from Miller Plumbing for the sewage pumps. Commissioner Scott Goodman applied the Epoxy at the district entrance step. Commissioner Robert Faugh and Commissioner Lawrence Meston to purchase padded chairs from Sam's Club.

**HOUSE #2:** Commissioner Michael Terzo reported Mike Terzo, Jr. power washed the house. Commissioner Scott Goodman spoke to the resident next door regarding the trees that need to be removed. Commissioner Scott Goodman to contact National Grid and to obtain a quote from O'Neill landscaping. Need documentation from National Grid regarding the trees.

**VEHICLE & EQUIPMENT MAINTENANCE:** Commissioner Michael Terzo has 3 quotes from Har-Rob for the removal of the AC brow light from the cab of the rescue truck and installing new 12 volt LED lights. The FRC Evolution 20K lumens 12 volt 2 light heads at a cost of \$3961.00 was chosen to be ordered.

Commissioner Robert Faugh will have the pump tests and maintenance performed at House #1 on August 23<sup>rd</sup> by Gorman.
