Roll Call: Chairman Robert Faugh called the meeting to order at 7:00 p.m. followed by the Pledge of Allegiance to the Flag.

Jason Schwartz, Bernard Donegan, Inc. reviewed the 2017 Proposed Fire District Budget.

A motion made by Commissioner Dale Sweet, seconded by Commissioner Michael Terzo and approved 5 to 0 to accept the 2017 Adopted Proposed Fire District Budget in the amount of \$342,595.00.

Secretary Statskey will file a copy of the proposed budget with the Town Clerk.

A resolution authorizing execution of letter for financial consulting services by Bernard P. Donegan, Inc. to the Rush Fire District for the next year. A vote made by Commissioners Robert Faugh, Scott Goodman, Michael Terzo, Lawrence Meston, and Dale Sweet approved 5 to 0.

REPORT FROM THE TOWN: Chief James Bucci reported the BOCES Lease Agreement was located and a copy was sent to Supervisor Cathy Frank. The two year agreement expires on December, 2016. Supervisor Cathy Frank gave approval for the Rush Fire to continue the use the facility and at the end of the year a new contract will be written up.

APPROVAL OF MINUTES: The Minutes of August 16, 2016, were approved with corrections under *New Equipment should read 2 cordless drills not grills and under Membership change Marsha to Marisa.*

A motion was made by Commissioner Michael Terzo, seconded by Commissioner Scott Goodman and approved 5 to 0 accept the Minutes of August 16, 2016, with the above corrected changes made.

AREAS OF CONCERN:

COMMUNICATIONS: None.

FIRE MARSHAL: Chief James Bucci and the Fire Marshal to meet with the Town Supervisor to work on a proactive plan regarding house #'s and driveway issues in the town.

NEW EQUIPMENT: Commissioner Michael Terzo reported firefighter Michael Terzo, Jr. has obtained quotes on voice boxes for the SCBA masks, new style \$379.00, old style still in the box \$50.00 a piece. 22 voice boxes were purchased at \$50.00 a piece. Commissioner Michael Terzo spoke regarding a quote of \$4100.00 for face pieces and bags combined with the purchase of the 22 voice boxes to use the Funke grant money to pay for the face pieces and the bags with the voice boxes. The fire department with reimburse the district for the purchase of the voice boxes.

HOUSE #1: Commissioner Michael Terzo reported that surveillance cameras are up and running. Secretary Colleen Statskey will send Dick Wheeler a thank you letter for his hard work with the chip removal and topsoil. Commissioner Robert Faugh reported the lights by the bathroom corridor between the kitchen and women's room are not working. Commissioner Robert Faugh will contact Larry Kaplan to look at the lights. Commissioner Lawrence Meston is trying to locate a cast iron piece control for the septic system. Commissioner Robert Faugh would like to run the generator with Commissioner Michael Terzo present to check the computers. Commissioner Michael Terzo will need to buy new UPS back up batteries.
