**Roll Call:** Chairman Robert Faugh called the meeting to order at 7:00 p.m. followed by the Pledge of Allegiance to the Flag.

**Present**: Commissioners Robert Faugh, Michael Terzo, Scott Goodman, Dale Sweet, Treasurer Robert Kuhls and Secretary Colleen Statskey.

Representing the Rush Fire Department was Chief James McNeil and President Duane Fanning.

Absent: Commissioner Lawrence Meston.

Representing the Town of Rush was Councilman Gerry Kusse

REPORT FROM THE TOWN: Councilman Gerry Kusse, President Duane Fanning and the Rush Fire Commissioners all discussed the flooding concerns in the hamlet during heavy rain storms. President Duane Fanning spoke with Assemblyman Joseph Errigo's office and filed a complaint. President Duane Fanning also spoke with Highway Superintendent Mark David. The flooding concerns were discussed further at length. Councilman Gerry Kusse will speak to the Town Supervisor Cathy Frank to include the Rush Fire Department and The Board of Rush Fire Commissioners to be a part of the meeting with the Town and the Engineer to voice their concerns and their individual knowledge concerning the flooding issues in the hamlet.

Commissioner Michael Terzo spoke with Fire Marshal Rick Tracy regarding the Town having a contract with a fire damage emergency enclosure company. Commissioner Michael Terzo, Chief James McNeil and Fire Marshal Rick Tracy will have a meeting to discuss a fire damage emergency enclosure company (Emergency Enclosures).

#### APPROVAL OF MINUTES:

A motion was made by Commissioner Dale Sweet, seconded by Commissioner Michael Terzo and approved 4-0 to accept the Minutes of October 17, 2017, approved as written.

## AREAS OF CONCERN:

**COMMUNICATIONS:** None.

FIRE MARSHAL: No report.

**NEW EQUIPMENT:** Commissioner Michael Terzo stated Firefighter Daniel Kwiecien has his new turnout gear. The two Assistant Chiefs have their new trial turnout gear at no charge. The specs have been upgraded from Morning Pride. Commissioner Michael Terzo has ordered four new 511 parka jackets for the new members. Commissioner Robert Faugh thanked Commissioner Michael Terzo for putting the new replacement inverter on 587 purchased by the Fire Department. Commissioner Michael Terzo has received the wench for the Kubota.

**TRAINING:** Commissioner Robert Faugh and Assistant Chief Mike Terzo, Jr. attended a class in Genesee County. The PESH Speaker spoke regarding the hour limit on training. Strongly recommends in house training with your own people and to have a lesson plan. No mandate to bail out anything more than the first story. Your members need to be competent and safe. Need to have documentation and proficiency. Turnout gear and anything else that is purchased for the members that is compliant and is still serviceable does not need to be replaced. "Line of Duty Deaths Always Involve Training or the Lack There Of". Concerning SOP's and SOG's the PESH speaker stated to write what the members are going to follow.

HOUSE #1: Commissioner Michael Terzo is still working the roof leak. The septic system box was replaced by Larry Kaplan. Larry Kaplan will contact Vern Vallance Company for the septic cleaning and Miller Plumbing for the pumps and Larry Kaplan will purchase a new box for the connector. Larry Kaplan looked at the plug in the kitchen and cannot figure out why the circuit is dead. Commissioner Dale Sweet put in two new LED lights and will work on the National Grid grant. Commissioner Michael Terzo stated the Backflow Test and the Sprinkler Test has been completed with no leaks on House #1 and #2. Monroe County has been notified. Commissioner Michael Terzo stated the Boiler was down and needed a new coupler. It was replaced and is working. Commissioner Dale Sweet received an email that the District Office doors have been unlocked on two different occasions.

**HOUSE #2:** Commissioner Robert Faugh, Assistant Chief Jon Faugh, and Bruce Hall removed the bushes and landscaping. Rochester Gas and Electric replaced the meter and raised it up. Photo electric cell on the flagpole is on all the time. Commissioner Michael Terzo ran the generator and works good. The gutters need to be cleaned.

**VEHICLE MAINTENANCE:** Commissioner Michael Terzo reported Har-Rob had 584 for a week and could not figure out the lights issue. 588 had an antifreeze leak with a missing plug and a pin hole in the radiator hose. Commissioner Michael Terzo reported new tires were put on the original rims on 587. Commissioner Michael Terzo reported \$360.00 was received for the original tires. Commissioner Michael Terzo reported the oil was changed on 587 and an inspection completed. All pump tests were completed.
