REPORT FROM THE TOWN: Councilman Gerry Kusse discussed the flooding in the hamlet.

APPROVAL OF MINUTES: The Minutes of the October 15, 2019, were approved with a correction under **HOUSE #1** to read cracked *small meeting room* window not kitchen window and correction under **NEW BUSINESS** to read Chairman *Scott Goodman* not Chairman Robert Faugh.

A motion was made by Commissioner Robert Faugh, seconded by Commissioner Dale Sweet and approved 3-0 to accept the Minutes of October 15, 2019, approved with a correction under HOUSE #1 to read cracked *small meeting room* window not kitchen window and correction under NEW BUSINESS to read Chairman *Scott Goodman* not Chairman Robert Faugh.

COMMUNICATIONS: None.

FIRE MARSHAL: No report.

NEW EQUIPMENT: Commissioner Robert Faugh reported the wheel chock is damaged on Rescue 588.

TRAINING: Assistant Chief Sean Brown stated training is up to date. Commissioner Dale Sweet spoke with Allison Paulson at Selective Insurance Company and no extra classes are necessary at this time for the Abuse/Molestation Insurance.

HOUSE #1: Commissioner Robert Faugh obtained a quote to repair the small meeting room window by G&G Window Repair, Inc. for \$300.00.

In the boiler room, the shelves need to be removed. The seam in the roof over the stairs to the back entrance to the large meeting room has a leak. The oversize bushes were removed by George Eiff along the west side of the building and replanted over at House #2. New landscaping was planted in its place.

HOUSE #2: Commissioner Robert Faugh reported the ants were removed from the generator. The overgrown bushes that were moved from House #1 have been replanted at the lot line near the next door neighbor to fill in the open space.
