Treasurer Robert Kuhls suggested that the adopted budget of \$356,420.00 be increased to \$638,078.40, this amount is due to the interest earnings, unclassified Earnings (Group 497 dividends, Rush Seniors Citizens) (NYS Grant monies) and transfer of funds from the Capital Reserve Equipment Type Fund – part one of the Communications project.

A motion was made by Commissioner Michael Terzo, seconded by Commissioner Robert Faugh and approved 4 to 0 to amend the adopted budget of \$356,420.00 to be increased to \$638,078.40. The distribution of monies to the Capital Reserve Funds (Equipment Type and Building and Property Reserve Accounts) that was budgeted and the remaining unexpended balances from the Contractual and Benefits portions of the 2020 was noted.

A motion was made by Commissioner Michael Terzo, that the sum of \$152,500.00 be transferred to the Capital Reserve accounts as follows: Capital Reserve Equipment Type Fund the sum of \$132,500.00, and to the Capital Reserve Building & Property account the sum of \$20,000.00, seconded by Commissioner Dale Sweet and approved 4 to 0.

The Treasurer was directed to make the appropriate transfers before December 31, 2019.

The Board decided to have the Organizational meeting on Thursday, January 2, 2020 at 5:00 PM. Commissioner Robert Faugh to add the Organizational Meeting date and time to the LED sign.

Commissioner Michael Terzo made a motion, which was seconded by Commissioner Dale Sweet and approved 4 to 0 to end the meeting. The meeting was adjourned by common consent at 5:37 PM.
