Meeting called to order 7:02 pm

Pledge of Allegiance

Roll Call: Commissioner Scott Goodman, Commissioner Doug Platt, Commissioner Dale Sweet, Chief Jon Faugh, Assistant Chief Mike Terzo Jr., Assistant Chief Dan Kwiecien, Treasurer Aletha Steehler, Secretary Kitty Stappenbeck

Absent: Commissioner PeeWee Terzo and Commissioner Bob Faugh

Also Present: Jim Princehorn from the Rush Fire Department, Councilwoman Jeanne Morelli from the Town of Rush

Report From the Town

- Councilwoman Morelli reported that the town has an estimate on the roof for Barn #3 in the amount of \$47,050. Would the district be able to replace the roof per Commissioner Sweet, NO because cannot use tax dollars to upgrade a non district owned building. Commissioner Goodman indicated the district will just wait for the engineer's report.
- Ms. Morelli brought the study of the water project she spoke about at the March meeting and shared with the board members

Approval of Minutes: Mar 19, 2024 - Commissioner Sweet had items to correct, but the minutes cannot be approved because we don't have a quorum of commissioners who were at the March meeting. One item to correct is to change the voting results - we were short one commissioner, so all of the motion approvals need to be changed to 4 - 0; the second item was under the bills: Commissioner Sweet also approved the bills; Approval will be moved to the May meeting. (Secretary made changes to the minutes and will distribute prior to the May meeting).

Tax Levy: Treasurer Steehler discussed the overpayment of the tax levy by the town. This was an error on the part of the town in picking up the budget amount including 'other income' from the budget summary delivered to the town. The tax was updated with the State Comptroller's website to reflect the \$20,500 overcollected by the town. The funds cannot be given back, as they were collected. The funds are now in a savings account and the tax levy for 2025 budget year will be reduced by that amount.

Chief's Report

The eclipse came and went - chief can stop going to meetings regarding planning. Not a lot of other issues to report.

Buildings and Grounds HVAC agreement was signed and sent to the vendor, per email from Commissioner Terzo.

Vehicles

- 588 sustained damage, Commissioner Terzo may have a fix for that (per Chief)
- Rescue truck and three pumpers were inspected; 587 is not due yet (per Chief)
- Meeting on refurbishing 582: input was made on what would be needed, will be put together and go out for bid (per Commissioner Sweet)

Equipment - no report

Information Technology

- The Lenel software maintenance needs to be paid as well as the invoice for software for the Lock box Commissioner Sweet has a concern about the box on 582. The knob on the lock box bumps against the windshield it moves. Concern if hard stop on the brakes, it may go through the windshield. Should be looked at.
- Email from President Sweet regarding updating the address list in Red Alert. No decision was made, email is attached to minutes

- Brian Ely started today April 16. He went on a couple of calls, but not in Red Alert yet so his activity can't be tracked yet. Secretary will put him in the system. Needs to be set up with training per Asst Chief Terzo.
- The laborer on duty today clocked in late and left early. Commissioner Sweet asked who would have been notified of this (mainly due to deliveries at the Fire Station). Conversation, but no real answer.
- John Morabito is all set to be onboarded
- Commissioner Sweet mentioned the email sent by President Sweet regarding updating addresses for the fund drive in Red Alert. (Email is attached). The Secretary will ask the assessor if it is possible to send a listing of just changes in the town street listing/homeowner instead of the entire listing.
